## **ORDINANCE NO. MTI-3159**

AN ORDINANCE PROVIDING FOR THE PUBLIC IMPROVEMENT OF A MAIN TRAFFICWAY – QUIVIRA ROAD FROM 159<sup>TH</sup> STREET TO 179<sup>TH</sup> STREET IN THE CITY OF OVERLAND PARK, JOHNSON COUNTY, KANSAS (PROJECT NO. TH-1665).

**WHEREAS**, K.S.A. 12-687 *et seq.* authorizes the Governing Body to improve or reimprove main trafficways; and

**WHEREAS**, on the 10<sup>th</sup> day of January, 1977, Quivira Road was designated a main trafficway by Ordinance No. MT-917; and

**WHEREAS**, it is the intention of the Governing Body of Overland Park, Kansas, to improve Quivira Road from 159<sup>th</sup> Street to 179<sup>th</sup> Street as hereinafter described; and

**WHEREAS**, all legal proceedings and requirements have been complied with for the public improvement of the main trafficway;

## NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OVERLAND PARK, KANSAS:

**Section 1.** That the following main trafficway be improved or reimproved as provided by K.S.A. 12-687 *et seq.*:

The reconstruction of Quivira Road from south of 159<sup>th</sup> Street to 179<sup>th</sup> Street. The reconstruction will include reconstruction from an unimproved 2-lane roadway to a divided thoroughfare with raised median, turn lanes, shoulders, sidewalk, multi-use trail and roundabouts. The project also includes construction of storm sewers, restoration, landscaping and other appurtenances and items incidental to the street reconstruction (the "Improvement").

**Section 2.** The estimated and probable cost of the Improvement is:

Twenty Five Million Dollars (\$25,000,000.00).

- **Section 3.** The Improvement shall be financed from revenue sources authorized by K.S.A. 12-689, including but not limited to the issuance of general obligation bonds.
- **Section 4.** The City expects to incur expenses in connection with the Improvement prior to the issuance of the general obligation bonds and temporary notes which will be used to finance the Improvement. The City reasonably expects to reimburse a portion of the expenditures in connection with the Improvement from the proceeds of the general obligation debt. This declaration is a declaration of official intent of the City under Treasury Regulations. The maximum principal amount of debt expected to be issued is Fourteen Million Five Hundred Thousand Dollars (\$14,500,000.00).

SECTION 5. This Ordinance shall take effect and be and publication as provided by law.	in force as of the date of its passage, approval
