

The risk of loss of such materials shall pass to the Buyer upon delivery to the Shipper. Time of delivery is not of the essence, and Seller will not be liable for any penalty, liquidated or otherwise, for late delivery. All shipping dates are approximate and are in any case dependent upon prompt receipt from the customer of all information necessary for the proper execution of the customer's order. In the event there is any delay in the receipt of such information the date of shipment may, at the Seller's option, be extended for a reasonable time, taking into consideration conditions at the Seller's factory at such time. The Seller shall not be liable for delay in delivery due to acts of God, acts of the Purchaser, fires, strikes, floods, epidemics, guarantine restrictions, war insurrections, riots, actions or civil or military authority, freight embargoes, car shortages, wrecks or delays in transportation, unduly severe weather, inability to obtain necessary labor or materials, or other causes beyond the control of the Seller. Where deliveries are to be made in one or more installments, whether of specified amount or not, each installment and each part delivery shall be paid for in accordance with the terms hereof, regardless of the claims of the Purchaser upon this or any other contract or relating to this or any other goods, and the failure to deliver any part of the installment shall not relieve the Purchaser from the obligation to accept and pay for other deliveries and installments under the contract.

INSPECTION AND CLAIMS: Any claims for shortages or damages must be reported to the Seller within 10 days of delivery of material. All material is packaged securely and shipped in good condition by the Seller. DO NOT STACK MATERIAL as damage may occur. All merchandise must be inspected by the Buyer. Any shipment which arrives with visible freight damage or missing packaging should be refused or inspected thoroughly with damages noted on the carriers freight bill. Claims must be made by the Buyer to the delivering carrier within 10 days after receipt of material. ANY ACTION FOR BREACH OF THIS CONTRACT MUST, IN ANY CASE, BE COMMENCED WITHIN TWO YEARS AFTER THE CAUSE OF ACTION HAS BEEN ACCRUED.

RESTOCKING CHARGES: In no case is merchandise to be returned to the Seller for credit without prior notification to the Seller and reasonable opportunity for the Seller to inspect the same at the premises of the Buyer. A Returned Material Authorization number is required and returned freight

property of the sender and the Seller shall not be responsible for the same. All material accepted by Seller for credit shall be subject to minimum restocking fee charge of 15%. All approved returned goods must be securely packed to reach the Seller without damage. Returned material will not be accepted after 90 days from the delivery date

WARRANTY: Crown USA, Inc. warrants its preformed thermoplastic against material defects or defects in workmanship to the original Buyer, for a period of 1 year from the date of delivery of goods. The warranty is the only warranty whatsoever, expressed or implied, relating to the products. If products are misused or altered in any way, the Seller will not be liable for any claims related to the products. Such misuse, alteration, or incorporation into other products, improperly stored or installed shall be deemed to be a waiver of all claims by the Buyer. Seller disclaims all other express or implied warranties, including, but not limited to, the warranties of merchantability and fitness for a particular use. It is understood, the Seller shall be given a reasonable opportunity to investigate products subject to any claim. Before using any product from the Seller, the Buyer shall determine the suitability of the product for the intended use. The Buyer assumes all risk and liability whatsoever in connection therewith. The Seller's limit of liability for damages. including but not limited to, direct, incidental, or consequential injury, loss or damage arising out of the use of or the inability to use the product, shall be to repair the defective product or provide an equivalent replacement product. The Buyer shall not make any representation or warranty with respect to the products to any person or organization without the consent of the Seller.

INTELLECTUAL PROPERTY RIGHTS: All intellectual property related to the products sold to the Buyer is the sole and exclusive property of the Seller. The sale of the products does not transfer any intellectual rights to the Buyer and the Buyer has no title or ownership to such intellectual property.

DEFAULTS: If the Buyer defaults in the performance of any of the terms hereof, or in any other contract between the Buyer and the Seller, the Seller may at its option, render bills at the contract price for all goods deliverable or appropriated hereunder and under any other contract between the Buyer and the Seller and the Buyer agrees to pay same in accordance with the terms hereof or in cash, at the Seller's option, or the Seller may rescind any transfer of the goods deliverable or appropriated hereunder or under any other contract with the Buyer, or cancel this and any other contract with the Buyer, reserving however all the Seller's rights with respect to any liabilities of the Buyer accruing prior to the cancellation. The Buyer, in the event of its default hereunder, shall be liable for the Seller's damages, including its loss of profits, reasonable attorney's fees, costs of collections, and interest thereon at the prime rate, in addition to other remedies the Seller shall have under law. In the event of bankruptcy, assignment for benefit of creditors, or appointment of receiver, or any other act of insolvency, the Seller may at its option, cancel and terminate this contract.

WAIVER: No claim or right arising out of a breach of this Agreement can be discharged in whole or in part by a waiver or renunciation of the claim or right unless the waiver or renunciation is supported by consideration and is in writing, signed by the aggrieved party. No waiver by the Seller of any default shall be deemed a waiver of any subsequent default.

ASSIGNMENT: The Buyer shall not assign or transfer this contract without the Seller's written consent.

RESOLUTION OF DISPUTES: Buyer and Seller waive the right to trial by jury and agree that any unresolved dispute or controversy arising under or in connection with the products shall be settled exclusively by arbitration in accordance with the rules of the American Arbitration Association (the "AAA") then in effect. Both parties agree to share the cost of arbitration equally. The decision made by the arbitrator shall be final and binding to both parties.

SEVERABILITY: If any provision of these terms and conditions is held invalid, such invalidity shall not affect other provisions of application of these terms and conditions that can be given effect without the invalid provision or application, and to this end the provisions of these terms and conditions are declared to be severable.

APPLICABLE LAW: The laws of the State of Georgia in force on date hereof, shall govern the construction and application of all terms and conditions of this contract. The Seller will comply with all applicable Federal and State laws and regulations issued pursuant to such laws which govern the Seller's performance hereunder.
