# **REMARKS:**

### 2020-7-27:

Valmont's drawing number A442928 Rev 1 with the 2020-4-16 revision is approved for use in the Sanders and Scafe parking lots. There is a single arm pole and a twin arm pole, each with 2' arms.

## 2023-8-15 Update:

The Valmont drawing number A42365 Rev 3 replaces the previously approved Valmont drawing number A442928 Rev 1.

Valmont's drawing number A42365 with the 2023-5-31 revision is approved for use in the Sanders, Scafe, and Fire Station 41 parking lots and their replacement poles.

There is a single arm pole and a twin arm pole, each with 2' arms.

This light pole is intended to be used for future city parking lots as it is designed to support IT's equipment.
